Our water source is a surface water source located north of Millheim.

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. The Millheim Borough Water Company routinely monitors for constituents in your drinking water according to Federal and State laws. This table shows the results of our monitoring for the period of January 1, 2010 to December 31, 2010. All drinking water, including bottled drinking water, may be reasonably expected to contain at least small amounts of some constituents. It's important to remember that the presence of these constituents does not necessarily pose a health risk.

In the table below you will find many terms and abbreviations you might not be familiar with. To help you better understand these terms, we've provided the following definitions:

Action Level (AL) - The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

Maximum Contaminant Level (MCL) - The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

Maximum Contaminant Level Goal (MCLG) - The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

Treatment Technique (TT) - A required process intended to reduce the level of a contaminant in drinking water

Mrem/year = millirems per year

ppm = parts per million, milligrams per liter (mg/L)

pCi/L = picocuries per liter (a measure of radioactivity)

ppb = parts per billion, or micrograms per liter (µg/L)

Our water system is also routinely monitored for total coliform bacteria. During 2010 we had no positive samples for bacteria. During 2010 we had a minor violation for late reporting. We were late in reporting the alkalinity results in the 3rd quarter of last year. Though these were violations, they did not affect the quality of water provided to our customers.

All sources of drinking water are subject to potential contamination by constants that are naturally occurring or man made. Those constituents can be microbes, organic or inorganic chemicals, or radioactive materials. The presence of contaminants does not necessarily indicate that the water poses a health risk. MCL's are set at very stringent levels for health effects. To understand the possible health effects described for many regulated constituents, a person would have to drink two (2) liters of water every day at the MCL level for a lifetime to have a one-in-a-million chance of having the described health effect.

Information about Lead

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Millheim Boro is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested.
