New Action Items:

Grubb Sewer Notice Letter:

Council members reviewed the letter as presented and as approved by solicitor. All agreed to have President Ilgen sign and send.

Warriner Reimbursement:

Council member reviewed receipts as presented, Robert Zeigler made a motion to approve payment to Ms. Warriner in the amount of \$690.62 for the 2017 and 2018 expenses seconded by Patty Beckenbaugh. Motion carried.

Radar Sign Update:

James Roman of PennDot has informed President Ilgen that the signs we have installed are not on the approved PennDot listing for liquid fuels funding. Mr. Roman and Mr. Painter of Traffic Logix are communicating for a viable solution. Mr. Roman has stated that if we disable the slow down function the signs would pass for funding. We will be requesting this in email or letter form for audit purposes.

Little League Mowing:

Over the past few years the Borough has been charging \$800.00 to the Millheim Little League for mowing the ballfield during the summer. Mr. Ilgen has received a request from a participant to have the Borough employees mow the lawn free of charge as the league is short on funds. Mr. Ilgen requested that representatives of the Little League come to a council meeting to present the request and discuss solutions.
